Dear Brother and Sister Members,

The regular monthly membership meeting of Wednesday, February 16, 2011, has been rescheduled to Thursday, February 10, 2011, six (6) days earlier. This will be a Special Order of Business Meeting beginning at 5:00 P.M., at which nominations for delegate to the 38<sup>th</sup> UA National Convention will be accepted and seconded from the floor.

Plumbers Local No. 1 may be entitled to as many as fifty seven (57) delegates, including the elected full time weekly salaried Officers. The number of delegates is based on the number of our members in good standing as of March 31, 2011. If Local 1 is entitled to fifty seven (57) convention delegates, the election will then be for forty five (45) delegates, (57 minus 12 elected weekly salaried Officers = 45).

As per section 17 of the United Association Constitution, "No member shall be eligible as a delegate or alternate unless he shall have been a good standing member of the Local Union which he is to represent for at least the two (2) continuous years previous to his election and he remains in good standing from the date of his election through the period of the convention."

The secret ballot machine election for Plumbers Local No. 1 UA Convention Delegates will be held on Wednesday, March 16, 2011. Polls will open at 4:00 P.M. and close at 8:00 P.M. Tabulation to follow.


In the event of a tie vote, a runoff election will be held on Wednesday, March 30, 2011 from 4:00 P.M. to 7:00 P.M.


All meetings and elections will be held at Plumbers Local No. 1 Trade Education Facility, 37-11 47<sup>th</sup> Avenue, Long Island City, NY.

As per Section 124 (a) of the United Association Constitution, "No member shall vote at any election of any description unless he has been a member in good standing in the Local Union where the vote is being taken for a period of one (1) year immediately prior to the date of election. Any member who owes or has paid a reinstatement fee within a period of one (1) year prior to the date of election shall not be eligible to vote in any Local Union election."

**Members must bring their signed membership card and one additional form of identification in order to vote.**
