IMPORTANT SST NOTICE!

BY LAW, YOU MUST RENEW YOUR 40-HOUR SST CARD EVERY 5 YEARS WITH <u>8 HOURS OF RENEWAL TRAINING</u>.

PLEASE READ ALL THE WAY THROUGH TO THE BOTTOM!

Trade-Ed is currently offering the Required 8 Hours of Renewal Training As: A 4-Hour "Fall Prevention" class and a 4-Hour "Supported Scaffold User" class.

BY DOB RULES, *RENEWAL TRAINING <u>CANNOT BE TAKEN EARLIER</u> THAN 12 MONTHS* **BEFORE YOUR EXPIRATION DATE**, and MUST BE COMPLETED <u>BEFORE</u> YOU APPLY FOR YOUR NEW CARD.

ANY RENEWAL TRAINING THAT WAS TAKEN <u>MORE THAN 12 MONTHS BEFORE</u> THE EXPIRATION DATE ON YOUR EXISTING CARD <u>WILL NOT BE VALID</u> FOR A RENEWAL.

BY TRADE-ED POLICY, YOUR APPLICATION AND TRAINING COMPLETION CERTIFICATES MUST BE SUBMITTED TO TRADE-ED AT LEAST <u>2 MONTHS BEFORE YOUR EXPIRATION DATE</u>.

SST renewal TRAINING and APPLICATION must occur during the 10 months BETWEEN: 1 year BEFORE your SST expiration date and 2 months BEFORE your expiration date Not before and Not after. **THIS GIVES YOU A 10-MONTH WINDOW TO ACT.**

You have THREE options to choose from to complete your SST-40 refresher training.

OPTION 1:

In-Person training at the **Training Center**. (*Training & Card provided to members at no charge.) 4-Hour Fall Prevention*

4-Hour Supported Scaffold User (This is NYC Course SCA-211 which grants a new Scaffold User Card.) The Member will <u>also receive</u> a NEW DOB 4-year Scaffold User card.

OPTION 2:

<u>Online</u> SST-40 refresher can be purchased at ClickSafety. There is a **35% discount** if done through the "Members Only" section of the local 1 website. *(SST Card produced by Trade-Ed at no charge.)* 4-Hour Fall Prevention

4-Hour Supported Scaffold User

(NOTE: Online course SCA-212 does not provide the member with a new Scaffold User card.)

OPTION 3:

If you choose to purchase services outside of Trade-Ed entirely, you can obtain your renewal training & SST card through any other DOB-Approved SST Training Provider. (*At your own expense*.)

In reference to Supervisor SST Cards:

IF YOU DO NOT WANT TO KEEP A "SUPERVISOR" CARD:

The NYC DOB will allow those with a "Supervisor" card to transition to a basic 40-Hour SST card if you wish to do so. You can do the standard 8-Hour renewal training and apply for a renewed 40-Hour card.

IF YOU WANT TO KEEP AND RENEW A "SUPERVISOR" CARD:

<u>Trade-Ed does not provide Supervisor SST training at this time</u>. However, Trade-Ed can issue a Supervisor SST renewal card based on valid third-party training completion certificates (16 hours) which have been submitted by a member. REMEMBER: Required renewal training <u>cannot</u> be taken earlier than 12 months before your expiration date, and that training must be completed before you apply to Trade-Ed for your new card. Your application and Supervisor training certificates must be submitted to Trade-Ed at least <u>3 months</u> before your expiration date in order to process a renewal. That gives you a <u>9-month</u> window between starting training and submitting your application to Trade-Ed. ClickSafety & others can provide the 16 hours of Supervisor SST training, but there is no discount.

WARNINGS

- 1) THE DEPARTMENT OF BUILDINGS HAS MADE IT CLEAR THAT THERE WILL BE <u>NO GRACE PERIOD</u>. AN EXPIRED CARD BARS YOU FROM THE JOBSITE, PERIOD.
- 2) <u>AFTER</u> YOUR CARD EXPIRES, IT CAN NO LONGER BE RENEWED, WHICH MEANS YOU WILL BE <u>REQUIRED TO DO A FULL 40 HOURS</u> OF TRAINING FOR A NEW SST CARD.
- 3) IF YOUR ORIGINAL CARD WAS NOT ISSUED BY TRADE-ED, THE RENEWAL MAY TAKE LONGER, SO TRAINING AND APPLICATION SHOULD BE SUBMITTED <u>3</u> MONTHS AHEAD.
- 4) IF YOUR ORIGINAL CARD WAS NOT ISSUED BY TRADE-ED, AND YOUR EXISTING DOB PROFILE IS <u>MISSING</u> ANY DOCUMENTS, YOU WILL NEED TO PROVIDE THE ORIGINAL DOCUMENTS FOR TRADE-ED TO DO THE RENEWAL.
