## NOTICE OF NOMINATIONS AND ELECTION OF OFFICERS

Dear Brother and Sister Members,

Please take notice that the regular monthly membership meeting originally scheduled for Wednesday, May 15, 2024, has been **RESCHEDULED TO TUESDAY, MAY 7, 2024 at 5:00 P.M.** The meeting will be held at Plumbers Local No. 1 Headquarters located at **50-02 Fifth Street, Long Island City, NY 11101.**

Upon commencement of this meeting, **nominations** for offices of **President, Vice President, Business Manager, Financial Secretary-Treasurer, ten (10) Business Agents, Recording Secretary, four (4) Executive Board Members, three (3) Finance Committee Members, six (6) Examining Board Members and one (1) Inside Sentry** will be accepted and **seconded from the floor.** The term of the offices is three years. The full-time salaried officers who are elected are required to serve as delegates to the United Association General Convention.

### **Important Information Regarding Eligibility for Office in Local Unions**

As per Section 121 of the United Association Constitution, "No member shall be eligible to be nominated for office in any Local Union unless he shall be a journeyman member and shall have been a member of the United Association and the Local Union in good standing for at least a period of two (2) years immediately prior to the election. Any journeyman member who owes or has paid a reinstatement fee within a period of two (2) years immediately prior to the date of the election shall not be eligible to be nominated for office in any Local Union."

Candidate eligibility will be determined after nominations are closed based upon records furnished by the United Association to Plumbers Local 1. Those candidates who are not eligible for office shall be notified of the reason for ineligibility by telephone or email. Any candidate who was declared ineligible to run for office and has evidence that he/she is eligible to run for office must present such evidence within 72 hours of the date of the notification. After review, a final determination of eligibility to run for office will be made and the candidate will be notified.

As per Section 20 of the Plumbers Local Union No. 1 By-Laws, Individual and slate nominations will be permitted. A group of nominees may be designated as a slate if they meet the eligibility requirements set forth in Section 121 of the United Association Constitution below and if the group includes a minimum of ten (10) candidates for elective offices.

**Important Information Regarding Eligibility  
to Nominate and Vote in Local Union Election**

As per Section 124 (a) of the United Association Constitution, "No member shall **nominate** candidates for or **vote** in any election of any description unless he has been a member in good standing in the Local Union where the vote is being taken for a period of one (1) year immediately prior to the date of election. Any member who owes or has paid a reinstatement fee within a period of one (1) year immediately prior to the date of election shall not be eligible to **nominate** candidates for or **vote** in any Local Union election."

**Eligibility to nominate candidates will be checked prior to the start of the Nominations Meeting on Tuesday, May 7, 2024 beginning at 4:00 P.M. and ending at 5:00 P.M. at the Union Hall.**

**The secret ballot machine election for Plumbers Local No. 1 Officers will be held on Saturday, June 1, 2024. Polls will open at 7:00 A.M. and close at 4:00 P.M. Tabulation to follow.**

**In the event of a tie vote, a runoff election will be held on Saturday, June 8, 2024, from 7:00 A.M. to 4:00 P.M.**

**Important Information Regarding Apprentice Voting**

As per Section 148 (b) of the United Association Constitution with regard to Apprentice Voting, Apprentices admitted to membership in Local Unions of journeymen shall be entitled to all of the monetary benefits of the United Association and, as learners, they will be entitled to attend meetings of such Local Unions. After successful completion of the third apprenticeship year, apprentices shall be entitled to voice and vote at Local Union meetings and in Local Union elections. Prior to the successful completion of the third apprenticeship year, apprentices will have no voice and vote except where this is necessary to comply with federal, state or provincial laws. Apprentices will not be entitled to hold office in any Local Union or in the United Association, and they will not be entitled to serve as delegates to the United Association Convention, until successful completion of their apprentice training and their achievement of journeyman status.

**All meetings and elections will be held at Plumbers Local No. 1's Headquarters, located at 50-02 Fifth Street, Long Island City, NY 11101.**

**Members must bring their UA membership card and one (1) additional form of identification in order to nominate, second, or vote.**
